Things to Know

If you prefer to bring your food for your pet(s):

-If you only feed your pet(s) dry food, it's best to have each meal individually measured into small Ziplock® bags. Otherwise, all food must be supplied along with either the measuring cup you use, a similar cup or exact measurement for each meal according to an everyday cooking/baking kitchen measuring cup.

-If what you feed your pet(s) is more involved than dry food or directly from a can, please prepare and supply individual meals in small Ziplock® bags or containers. If your trip will be long, we can freeze what doesn't get used immediately and thaw a serving for each meal.

-Please label all food and containers with your pet's name!

-Be sure to always send at least three (3) extra meals in case your travels are interrupted or extended, or to have in case of emergency.

Optional items:

Bedding, blankets, sweatshirts, pillows, etc., that are familiar to them.

(Note: We do provide bedding for all pets, unless we are directed otherwise.)

Chew toys, bones, Kongs®, tennis balls, etc.

Please Note:

Dogs must be on a leash, and cats confined in a cat carrier coming in and out of the building.



Boarding Contract

Contract between Paws + Claws Rescue & Resort, hereinafter called "Kennel", and the Pet Owner whose signature appears below, hereinafter called "Owner".

Owner specifically represents that he or she is the sole Owner of the pet or has the permission of the owners to board the pet.

I certify my pet(s) appear to be free of contagious disease, including external parasites and has/have not bitten anyone within the last 10 days.

I understand that if my pet(s) have been found to have any external parasites, they will be treated and my account will be charged accordingly. I also certify that my pet(s) is/are current on all required vaccinations and have provided written documentation of the same. I understand that it is **recommended** that all dogs be vaccinated against Canine Influenza. If on entry my pet is found not to be current on required vaccines, I understand that my pet will not be able to board until required vaccines have been completed. I also certify my pet is heart worm free.

If in the event my pet becomes ill or if the state of the pet's health requires professional attention, the Kennel will first contact you and/or your vet. In its sole discretion, may engage the services of a veterinarian, administer medicine, administer a special diet or give other requisite attention to the pet and the expenses will be paid by the Owner. If my pet passes away while boarding at the Kennel, the Kennel will immediately attempt to notify the Owner and/or the emergency contact information left by the Owner.

The Owner agrees that the Kennel assumes NO ownership or guardianship, and therefore no liability associated with the animal. The Kennel shall exercise reasonable care for the pet delivery by the Owner to the Kennel for boarding. It is agreed by Owner and Kennel that the Kennel's liability in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$300 per animal boarded. While

you're pet(s) is/are staying with is, the pet(s) may come into contact with other pets depending on the services you have contracted. You acknowledge and agree that in the unlikely event

that your pet(s) is/are injured by another pet, the Kennel will not be held responsible for the injury. If you're pet(s) injure(s) another pet or person while in our care, the Owner will be solely responsible for any injury sustained.

The Owner also acknowledges that dogs that are kenneled together are from the same household. The Owner also assumes all responsibility for any aggressive behavior, fighting or injury that one dog may inflict upon another while they are together. The Kennel reserves the right to separate any dogs who are boarding together at our discretion of the dogs' own safety. If your dogs are not comfortable boarding in the same kennel unit, you will be billed and responsible for the cost of more than one kennel. The Kennel is not responsible for loss or damage to any personal item belonging to your pet. Do not bring toys, blankets, beds, etc. that are valuable or irreplaceable.

Owner agrees that the pet(s) shall not leave the Kennel until the Owner pays all charges to the Kennel. By singing this Contract and leaving the pet(s) with the Kennel, Owner certifies the accuracy of all information given about said pet(s) and consents to photographs of the pet while in our care that may or may not be used for marketing purposes.

I understand that if I fail to pick up my pet(s) within 10 days of the mutually agreed upon pickup date, my pet(s) will be considered abandoned and will be handled in accordance with the Minnesota State Law and doing so does not relieve me of my financial obligation.

Holiday rates apply for the following dates: New Year's Eve/Day, President's Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas Eve/Day.
